



**Information on data processing  
pursuant to Articles 13 and 14 DSGVO  
- Data processing of customers (B2B) -**

We hereby inform you about the processing of your personal data (personal data is all data relating to you as a natural person):

**DATA PROCESSING**

We - the SUGGLE GmbH - process the personal data with regard to your person as a contractual partner of your company out of our legitimate interest for the preparation of offers and for the fulfilment of contracts on the basis of Art. 6 para. 1 lit. f DSGVO. Processing for the purpose of accounting and cost accounting as well as for the fulfilment of legal obligations (e.g. commercial and tax law) is based on Art. 6 para. 1 sentence 1 lit c DSGVO. The business relationship exists between us and your company. If you act as a natural person (e.g. as a sole trader or self-employed person), your data will be processed for the purpose of implementing pre-contractual measures and fulfilling contracts on the legal basis of Art. 6 para. 1 lit. b DSGVO.

In the course of external requirements (e.g. within the framework of customs and tax law), personal data relating to you may be compared with lists published by the authorities.

Furthermore, data is also processed for legitimate purposes pursuant to Art. 6 para. 1 sentence 1 lit. f DSGVO, such as marketing, internal market research and marketing purposes, internal statistics. The legitimate interests lie in particular in the optimisation of processes and the allocation of costs; here your interests, fundamental rights and fundamental freedoms are duly taken into account.

We will only use your data to send you information about products, services, events and other interesting facts about our company if you have given us your consent to do so or if we have provided you with appropriate information within the scope of data collection in accordance with § 7 UWG. You can object to this sending at any time with effect for the future.

The data provided by you is necessary for the execution of the contractual relationship. Without this data we cannot fulfil the contract concluded with your company.

**FORWARDING**

Some of your personal data will be passed on to external service providers (e.g. tax consultants, legal advisors). In some cases, external IT service providers can access your data (as part of order data processing in accordance with Article 28 DSGVO). The service providers act in accordance with instructions, which is ensured by corresponding contracts.

**STORAGE AND CLEARANCE OF DATA**

Your data will be stored for as long as is necessary for the above purposes. The data will be deleted at the latest after termination of the contractual relationship and after expiry of the statutory retention periods of civil, commercial and tax law.

## YOUR RIGHTS
