

## Information on data processing pursuant to Articles 13 and 14 DSGVO

- Data processing in the context of the application procedure -

Herewith we inform you about the processing of your personal data:

#### DATA PROCESSING

We - the SUGGLE GmbH - process your personal data with regard to your person in connection with the execution of your application procedure as well as for the examination of your potential job-related employability. We process the information provided by you for the purpose of an informed personnel decision on the basis of Art. 6 Para. 1 S. 1 I lit. b DSGVO. In addition, evaluations are stored on the basis of objective, non-discriminatory criteria; insofar as this is permissible in individual cases, publicly accessible personal data relating to you will also be stored.

The data you provide is required for the application process. Without this data we cannot consider your application.

#### TRANSFER / SERVICE PROVIDER

Only if you have given us your consent within the scope of your consent will we pass on your personal data to other companies in our group of companies in order to give you further entry options into our group of companies.

#### STORAGE AND DELETION OF DATA

Your data will be kept for as long as is necessary for the above-mentioned purposes of the personnel selection procedure. If you object to the data processing during the personnel selection procedure, the data will be deleted unless there are other legal storage obligations to the contrary.

The data will then be deleted after completion of the application procedure and after expiry of any time limits for filing suit, unless you have given your consent to save your application for further job offers. Unsolicited applications will be stored for a maximum of two years or until your revocation and then deleted.

### YOUR RIGHTS

We would like to inform you that, pursuant to Articles 15 et seq. DSGVO under the conditions defined therein have the following rights of the data subject: Right to information about the personal data concerned as well as to correction or deletion or to restriction of the processing or right of objection against the processing as well as right to data transfer. Pursuant to Article 77 DSGVO, you also have the right to lodge a complaint with a data protection supervisory authority. If the processing is based on Article 6 paragraph 1 letter a DSGVO or Article 9 paragraph 2 letter a DSGVO (consent), you also have the right to revoke the consent at any time without affecting the lawfulness of the processing carried out on the basis of the consent until revocation.
